WVPAL Background Check Criteria

When reviewing criminal backgrounds the Executive Director will use these guidelines as a reference for granting volunteer participation in WVPAL.

Automatic Disqualifiers Prohibiting Volunteering with WVPAL: Any conviction for a crime against a child, the elderly or sex crimes. Regardless of whether the sentence was suspended, adjudication withheld, you pled no contest, or the conviction was sealed or expunged.

- Convicted of a violent felony or conspiracy to commit a violent felony within the past ten years.
- Convicted of a non-violent felony or conspiracy to commit a non-violent felony within the past five years.
- Convicted of a felony or misdemeanor involving the trafficking, selling or possession of a controlled substance within the past five years.
- Any misdemeanor within the past ten years that would be considered a potential danger to a child or young person or is directly related to the functions of that volunteer.
- Has been convicted of any misdemeanor within the past two years.
- Any convicted cases of Domestic Violence within the past two years.

For the purpose of grandfathering current volunteers that may not qualify using these new criteria the Executive Director reserves the right to review the information based upon frequency of arrest, type of charges, convictions and how the applicant has improved their lifestyle since the last arrest.

Pending Cases: Anyone who has been arrested/charged for any of the disqualifying offenses or for cases pending in court will not be permitted to volunteer until the official adjudication of the case.
